

FIA DOCUMENTATION GUIDELINES- FOR CLOSED CORPORATIONS

This guideline should be used to assist you in preparing the necessary documentation that our Corporate Guarantee Risk Consultant will need to process your request to open a policy with us.

This documentation is required by law, as stated in the Financial Intelligence Act (13 of 2012).

If the policyholder is registered as a Closed Corporation:

CC1 - Founding Statement, containing Certificate of Incorporation
CC2 - Latest Amended Founding Statement
CC8 - Defensive Name (If different to the registered name)
Proof of Bank Account (Bank letter or Bank statement not older than 3 months)
Income Tax Certificate and VAT Certificate (if the business is a VAT vendor)
ID's of all the Members of the Closed Corporation
Control & Ownership Structure (indicating Beneficial Owners and the CEO/Executive Manager)
- FIA records (Natural Person) in respect of all partners owning more than 20%
- 'Natural Persons' FIA information in respect of the Managing Partner
Source and Purpose of Funds Declaration for Non-Individual (This can be found on our website-Additional Documentation)
Proof of Business Address
Proxy letter / Resolution – (If applicable)
